We specialize in **INTENSIVE** outpatient treatment (IOP) by providing two programs:

### **Mental Health IOP & Substance Abuse IOP.**

Both Programs are designed for **adults** from age 18 and older. Programs are conducted in a pleasant private environment, **9** hours of treatment per week (**3** days a week / 3 hours a day) with duration of 6-8 weeks.

**The Substance Abuse Program offers a unique Pain Management Track for clients who, while being under care of a pain management physician, develop the symptoms of addictions to opiates, or wish to prevent the addiction from occurring. We collaborate with your doctor so that pain management treatment can continue successfully.**

## MENTAL HEALTH IOP

The program is confidential and executed by Clinically Licensed Psychotherapists.

### **Convenient daytime hours:**

**Mon, Tue, Thu from 10 am to 1 pm.**

### **Who is the right client for MH IOP?**

**Functional adults**, who have just been discharged from the hospital, and need more time for full recovery, or clients who are:

- Not making enough progress in regular outpatient treatment
- In mental health crisis but not in danger to self or others
- Unable to function at work and/or fulfill family obligations

**Attendance of Mental Health IOP usually makes participants eligible for short/long term disability.**

**The Program Curriculum** includes:

- Comprehensive Psychiatric Evaluation
- **Medication Management**
- **6 weeks** of Intensive therapy in **small** group setting (up to 8 people)
- **Unique combination** of group, individual, and family therapies
- **Aftercare:** a weekly 1-hour Support Group, which can be augmented with an individual therapy session scheduled at a time convenient for the patient

## SUBSTANCE ABUSE IOP

The program is confidential and executed by Clinically Licensed Addiction Professionals.

### **Convenient evening hours:**

**Mon, Tue, Thu from 5:30pm to 8:30pm.**

### **Who is the right client for SA IOP?**

**Functional adults**, who just graduated from a SA rehab and would like to continue the recovery process or clients who would like to address and resolve:

- Dependency on alcohol/recreational drugs/prescription medicine that causes problems at work, family, interpersonal relationships
- Abuse of alcohol/drugs to compensate for a mental health problem or cope with ordinary life stressors
- Legal problems due to substance abuse (DUI, disorderly conduct and etc.)

**Attendance of SA IOP can help participants to prove to legal system their intention to maintain sobriety**

Important advantages of our SA IOP are:

- **6 weeks** of Intensive therapy in **small** group setting (up to 8 people).
- **Unique combination** of group, individual, and family therapies
- Full Confidentiality
- **Aftercare:** a weekly 1-hour Sobriety Support Group, which can be augmented with an individual therapy session
- Our SAIOP is affiliated with **Florida Board of Impaired Health Care Professional**
